- 5.Safety Declaration.
- 6.User Manual, if any.
- 7.Sample for testing and/or inspection purposes, if this is deemed necessary by TRC.
- 8.Any other documents deemed necessary by TRC.

B- The applicant shall pay the declared fees (the application fee and testing fee are non refundable).

Notes:

- Each page of this Application must be stamped by the applicant.
- All documents must be submitted in either Arabic or English.
- Application without the submission of complete documents will not be accepted.
- Payment should be made by a crossed cheque/cache payable to "Telecommunications Regulatory Commission" or "TRC".
- Only equipment from the declared source of import is allowed to be marketed and sold in Jordan. The applicant will be required to re-apply for a new type approval if the source of import has changed.
- TRC reserves the right to reject any equipment .
